- Vehicles and/or Scenes must be set up along the dirt service road behind the Community Center NO LATER than 5:15 PM. Parking attendants will direct you where to park. Your vehicle or scene can be as simple or as detailed as you want. We encourage folks to make it “not too scary this year” as this is a family themed event.
- You should supply parks and recreation candy for 250 children. We have received sponsorship to purchase the rest of the candy. We ask that you deliver your candy/treats/promotional materials to the Community Center no later than October 23<sup>rd</sup> so we have sufficient time to make the 500+ goodie bags. (Business Sponsorships Available)
- For your safety you will not be allowed to move your vehicle from the event area until after all participants have cleared the trail exit. We will ask you to stay in the area of your vehicle/scene and not walk around the trail. No unaccompanied minors will be allowed in the event area.
