4. Approval of the Regular Agenda ~

A *motion* was made by Commissioner Guzulaitis, a *second* by Commissioner Barger approving the agenda for the Board of Commissioners Meeting of October 6, 2020.

5. Recognition of Police Officers ~ Chief Greg Jordan

Officer Eric Mahoney ~ Chief Jordan awarded Officer Mahoney with the Chief's Commendation Letter and Pin and recognized Officer Mahoney for possibly saving the life of an individual who was in need. Officer Mahoney offered assistance to the individual, provided food and beverage and personally transported this individual to a rehabilitation center. With this act of selflessness, Officer Mahoney has made a difference in someone's life. This individual notified Chief Jordan and informed him that he has been drug free for over seven (7) months and that Officer Mahoney has changed his life forever.

Officer Megan Wells ~ Chief Jordan explained Officer Wells noticed smoke coming from a home and notified Central Communications to alert Fire/Rescue to respond. There were no residents in the home at that time, however Officer Wells saved the lives of a number of pets. Chief Jordan presented Officer Wells with the Chief's Commendation Letter and Pin. Officer Mahoney nominated Officer Wells for this award.

Captain Kevin Smith ~ Chief Jordan explained Captain Smith was instrumental in solving a 25 year old murder cold case last year of a missing person back in 1995, Mr. Timothy Smart. In March 2019 Captain Smith found leads in the case. He was able to search the area where Mr. Smart's remains were found. By Captain Smith's continued investigation

he was able to bring closure to Mr. Smart's family. Captain Smith was awarded the Chief's Commendation Letter and Pin.

Captain Smith was recommended to receive an award from the Veteran of Foreign Wars Post 10400, our local VFW. The Award presented to Captain Smith is a Certificate of Appreciation in recognition as the VFW National Law Enforcement Public Servant Citation as Officer of the Year and received a recognition pin.

That the Letters of Commendation for the Officers is hereby incorporated by reference and made a part of these minutes.

6. Presentation ~ Fire Chief Theresa Tickle

Chief Tickle stated in December 2019 we were able to replace our ladder truck that was 33 years old. We tried to sell the truck, but to no avail. Fire Chief Jeffrey Stotesberry reached out to Chief Tickle stating the truck would be such a blessing to their Fire House in Swan Quarter. Chief Tickle then contacted their membership and all were in favor of donating this truck to the Swan Quarter Volunteer Fire Department.

Two weeks later Chief Stotesberry and his team traveled to BSL to pick up the truck. Chief Stotesberry thanked the BSL Fire House and community for their donation. Chief Stotesberry stated they are so blessed to meet such wonderful and caring people. We are so appreciative.

10. Committee / Board Reports and Minutes ~

a. Community Appearance Commission ~ Ms. Ann Hollingsworth Ms. Hollingsworth invited Chief Tickle and the nominee for the Certificate of Appreciation to come forward.

The Community Appearance Commission contacted the Fire Chief, Police Department, City Hall and Community Center if they had a volunteer that has gone above and beyond what has been asked of them to do. Chief Tickle nominated Sara Crissman Edge. Mrs. Edge is not a department employee, however Mrs. Edge has given so much of her time and support to the Fire Department. She is married to a BSL Firefighter.

Ms. Hollingsworth reported the Commission chose three commercial properties for recognition this year. We see all the work that has been done by Buildings and Grounds here at City Hall, the new sign at the Fire Department and keeping the grounds so neat. We would also like to thank so many people for all the hard work and dedication to our Community Garden. We would like to recognize Karen and Mike Hartigan, Commissioner Tom Guzulaitis, Rick Cushman, Billie Jean and Woody Smith, Janet Carlisle, Gene Helbig and Pat Elliott for all their efforts and hard work.

b. Planning Board ~ Mr. Bill Clark, Chair

Commissioner Witt reported for Mr. Clark

The Planning Board met on Tuesday, September 8, 2020 and approved the request submitted by Mary Green to rezone numerous city owned properties from residential to recreation. This was tabled last month and approved for the October agenda. Both the zoning map amendment and the consistency statement were also approved. Under Old Business, Mr. Endress was not satisfied with our resolution to his dock issue at our August meeting, however we have not heard back from Mr. Endress as of September's meeting.

c. Parks & Rec. Advisory Board ~ Chastity Rosebrock

Mrs. Rosebrock reported the Comprehensive Pedestrian Plan has been completed and will be brought to the Board of Commissioners for adoption at the November 4, 2020 meeting. The Board would like to thank the Cape Fear Council of Government, North Carolina Department of Transportation, AECOM and the Steering Committee and Staff for all of their work on this plan to make the City of Boiling Spring Lakes a walkable community in the future. The Community Center has reopened to the public, the current hours are Monday through Friday, 7:00AM to 8:00PM. The fitness room is open by appointment only. Youth and adult programs are scheduled throughout the week. Continued conversations on the possible development of North Lake Park have continued. The Parks & Recreation Advisory Board has included information in your agenda packages in regard to the purchase of two additional lots adjacent to the current park. We urge the Board to consider these lots for purchase as soon as possible.

d. Special Events ~ Commissioner Hall

Commissioner Hall reported the Committee did not meet in September, however they will be meeting this month.

e. Library Commission ~ Commissioner Witt

Commissioner Witt reported the Library Commission will not hold a meeting next week, but will meet in the month of November.

f. BSL Fire/Rescue ~ Chief Theresa Tickle

- Chief Tickle reported for the month of August we had 22 medical calls, and 29 fire calls. We are still only responding to Delta/Echo.
- o Mutual aid training was held with Bolivia this month, this helps with our ISO training.
- o Our open house recruitment day was held with a good turnout.
- o Smoke alarms are still available, if anyone is in need please just give us a call to make an appointment.
- On October 17, 2020 we will be holding our annual BBQ plate sale starting at 11:00AM which will run until we are out of food.

11. City Manager's Report ~ Mr. Jeff Repp

City Manager Repp reported:

- o As of August 30, 2020, the City had \$1,488,765 in cash and investments.
- We had a very good quarter for sales tax revenue considering what we were projecting. We are currently 12.9% ahead of schedule. The October report will give us a better idea of where we will be in the November/December timeframe. At that time, we can then decide if we should lift the hiring freeze, as well as some other projects.
- O Property tax collections for the quarter, July, August and September, were at 19.48%. The big months for collections will be October, November and December. We are not seeing any delay in citizens paying their taxes.
- We did receive a slight reduction in our Powell Bill Revenue. In July 2020 the General Assembly deleted appropriations of \$7.35 million to the Powell Bill in FY 2019; also removing \$10.42 million in nonrecurring funds. All cities and towns saw approximately a 10% reduction for the FY 2021, bringing us to \$293,580 from 2020, which was at \$310,083.
- We received 12 new residential building permits, which were issued in August. We have budgeted for 50 this year and have exceeded that number. We are currently at 56.
- We received notice from NCDOT informing the City they are planning a closure at the intersection of E. Boiling Spring Road and the MOSTU Road. The railroad material in that area needs to be replaced. We have several questions which have been sent to NCDOT to get further information as to the duration of time for the closure, to date we have not had a response.
- The renovations for the new Police Department are scheduled to go out for proposals after the first of the year.
- O Update on City personnel ~ we have received two notifications of resignations. Karen Thompson has announced her plans to retire effective December 1, 2020. Karen's position is essential to fill. We also have the resignation of Jackie Roman at our Police Department, which is effective October 13, 2020. We have existing frozen vacancies, two (2) in Public Works and one (1) in Parks & Recreation. With the hiring freeze, no positions were to be filled between June through December.

- The update on the Special Assessment District as it relates to the sewer system ~ out of 328 total lots involved in the project, we have received full payment from 238 owners. We have 45 owners who have arranged to go with the three (3) year payment plan. Currently, to date we have not heard from 43 owners; however, we will be sending letters out to those owners again.
- On September 18, the City held Industry Day, which was followed by a workshop with the BOC to bring everyone up to speed on the 60% drawings moving on to 90% drawings. I sent an email out today responding to our PDMG with FEMA to provide us an update on the two projects we have remaining on the storm event. Sanford and Upper Dam ~ we are awaiting their determination if this project will be a repair verses a replacement project. A determination will then be made on what will be covered. Additional information was requested on North Lake and Pine Lake, which has been provided to McGill Associates.
- A meeting was held with Dam Safety to review the concepts the City is proposing for the Middle Dam. Dam Safety has approved the drawings, which will provide a dam that will have a 250 ft. structure that will be at the water level.

Commissioner Witt clarified the current Bett Lane will be renamed to Pamlico Road in order to maintain the access to the private property which will be renamed Bett Lane.

d. Order ~ appointing Sheryl Johnson to the Parks & Recreation Advisory Board completing the term ending November 8, 2020; and Barbara V. Reynolds to the Community Appearance Commission completing the term ending April 3, 2022.

A *motion* was made by Commissioner Barger, a *second* by Commissioner Hall appointing Sheryl Johnson to the Parks & Recreation Advisory Board completing the term ending November 8, 2020; and Barbara V. Reynolds to the Community Appearance Commission completing the term ending April 3, 2022.

e. - g. Request for Public Hearing to rezone properties from residential to recreation ~
 - a. Zoning map amendment for properties on North Lake, Spring Lake, Pine Lake, Community Garden, Alton Lennon, Shadow Lake, Silver Lake, Seminole Lake, Lake Keziah, Harper Lake and Frink Lake to be set for the November 4, 2020 Board of Commissioners Meeting.

b. Zoning map amendment for properties on Lake Middleton, Lake Reeves, Lake Hastie, Schneider's Park and Mirror Lake to be set for the December 1, 2020 Board of Commissioners Meeting.

A *motion* was made by Commissioner Barger, a *second* by Commissioner Witt for discussion.

Commissioner Barger commented we should not be rezoning private property without the property owners request or consent. I will not condone this and hope these properties are removed.

The Board requested Mary Green, Director of Parks & Recreation to comment. Ms. Green explained this was requested to be consistent with the Comprehensive Plans that we are laying out. These are deeded, platted as map areas, but they are not zoned as park areas. We are trying to get consistent as to how things are reading and worded. Ms. Green also agreed that private properties should not be listed for rezoning.

A *motion* to amend was made by Commissioner Barger, a *second* by Commissioner Witt to hold the public hearing, removing the three (3) private properties. Two (2) at North Lake, property numbers 142PA00901, 142PA00204 and one (1) at Lake Reeves, 157OF001.

14. Discussion ~

a. Acquiring two parcels at North Lake Park ~ Commissioner Guzulaitis

Commissioner Guzulaitis informed the Board we have been able to acquire two (2) properties at North Lake in the last year. There are two end parcels, currently these two (2) lots are unbuildable failing perk tests. We have to be prepared to stay ahead of the growth coming to our City. There is a good opportunity for our City to develop something special with the purchase of the lots.

A *motion* was made by Commissioner Guzulaitis, a *second* by Commissioner Hall to purchase the two properties at North Lake Park.

 $Vote \sim 2 \sim to \ 3 \sim$ (Commissioner Guzulaitis and Commissioner Hall were in favor. Mayor Caster, Commissioner Barger and Commissioner Witt were opposed to the purchase.) Motion Failed

b. Lifting the hiring freeze ~ Commissioner Hall

Commissioner Hall commented about the hiring freeze that was imposed in March has placed a strain on Public Works. We have two office managers and not enough "boots on the ground." I would like to suggest we reinstate two (2) of these positions.

A *motion* was made by Commissioner Hall, a *second* by Commissioner Witt to reinstate two (2) of the positions for Public Works.

City Manager Repp recommended waiting until the City receives the sales tax revenue from the County in October and see where we are at that time after a review of the numbers. Following the review, we can then add the lifting of the freeze for certain positions at that time.

After a discussion ensued, Commissioner Hall withdraw the motion.

A *motion* was made by Commissioner Barger, a *second* by Commissioner Witt amending the motion to modify the hiring freeze to only include the equipment operator and the community center position. In addition to filling the maintenance technician and the finance manager positions.

On May 03, 2019, you responded to call at Spring Lake Park in reference to a homeless person staying in the park. Upon arrival, you met with a Mr. Zackery Manning from the state of Georgia. Mr. Manning indicated that he wanted to go for Drug Rehabilitation in Wilmington and, though you could not take him at that moment, you did furnish him with water and asked him to stay in the area until you had completed other calls. At about 15:00 hours on that day, you did offer food and beverage and transported him to Launch Pad Rehab in Wilmington.

On January 21, 2020, Mr. Manning called me, the Chief of Police, to state that he had been "clean" of drugs for seven months and he credited your actions for helping him to get clean. He noted how nice and caring you were and stated that you quite possibly saved his life.

Sometimes, a small act of kindness is all that is needed to change a life and you seized the opportunity with this encounter. Your actions went well beyond the call of duty and were truly admirable. They reflect positively on you and the Boiling Spring Lakes Police Department, and these actions reflect the compassionate side of the law enforcement profession. I am very pleased to have you as an officer and a mentor with the Boiling Spring Lakes Police Department and am truly grateful that you are here for the citizens of Boiling Spring Lakes.

In 2014, you started looking into a cold case of a missing person, Timothy Smart, from 1995. Though it took a while, in March of 2019 you, with the assistance of the North Carolina State Bureau of Investigation, developed new leads in the case. Upon following up on those leads, you obtained enough information to arrest an individual for the murder of Mr. Smart. Though many areas were searched in the late 1990's and early 2000's, at the time of the arrest, Mr. Smart's remains still had not been located. Upon studying the details of the case, testimony and maps, you visited several possible locations and determined there was one place that warranted a thorough search. Within 20 minutes of the start of the search, Mr. Smart's remains were located.

Your actions and determination went well beyond the call of duty and were truly commendable. Not only were you unwavering in your pursuit of justice, you were able to bring closure to a family and allowed Mr. Smart to receive a proper burial. Your activities reflect positively on you, the Boiling Spring Lakes Police Department, and on law enforcement as a profession. While I am very pleased to have you as a member of our team, the citizens of Boiling Spring Lakes can certainly be proud of your actions and can be grateful that you are here for them.

Award: VFW National Law Enforcement Public Servant Citation

In every occupation, there are people behind the scenes whose work – though important – often goes unnoticed. The bus drivers that get children to school safely, the Lab Technicians who help confirm a doctors diagnosis and countless others that do amazing things just by "doing their jobs." In law enforcement, often the police detective is overlooked. On television, detective and investigative work is portrayed as enjoyable, full of excitement and extremely dangerous, but in reality, it is not quite that way. There is an element of danger as with all police work but Detective work consists of a great deal of paperwork and documentation. Detectives carry a load of several cases at any given time and they must be flexible as they might be questioning a suspect in a simple larceny one minute and thirty minutes later, they may have to speak to a child, who was the victim of a crime. In addition, and especially in smaller jurisdictions, Detectives must be knowledgeable in a variety of areas (crime scene, computer forensics, interviewing/interrogating etc.) because they do not have the specialized units often found in large departments. To further this, cases become delayed as results for evidence submitted to the lab take months instead of hours and witnesses are reluctant to get involved. To make it even a little more discouraging, a case can be worked for months just to fall apart when it is learned that a victim or witness was untruthful in their statement. Because of this, it takes a special person with patience, determination and skill to be a detective. Kevin Smith of the Boiling Spring Lakes Police Department is such a person.

It is doubtful that the case would have been solved without the relentless efforts of Detective

Kevin Smith. Furthermore, it is with great certainty that the remains would have never been

found had it not been for his determination. The wooded area where the remains were

suspected had been searched several times in the past, but the initial search areas were several

hundred yards away from where the remains were eventually located. It was only after careful

scrutiny and study of the case and area - as well as several walk-through searches - that

Detective Smith was able to pinpoint the correct location of the remains.

This is just one example that shows Detective Smith will go to great lengths to help the victims

of crime. This case took a great deal of time and while he could have spent most of his time on

this, Detective Smith did not forget about his other cases. During the May through September

time frame, Detective Smith also worked on several child abuse and other serious cases simply

because he felt it was owed to the victims. Even more so, during this time, Detective Smith

completed his Bachelor's Degree in Criminal Justice from Liberty University and he received his

Advanced Law Enforcement Certification from North Carolina Criminal Justice Training and

Standards.

While this case may be considered a career defining case, it is just a sample of the strength of

character that Detective Smith has portrayed over several years in Law Enforcement. He is

passionate about helping victims of crime and will do what it takes to ensure a successful

resolution of a case. For his unwavering commitment to law enforcement, Detective Kevin

Smith deserves recognition.

Background:

In 2018, a 1995 missing persons case from Boiling Spring Lakes was featured on the "Unsolved" series on WWAY News - a local television station newscast.

With that case, Timothy Smart, a truck driver from North Dakota, went missing in July of 1995 and was last seen in Boiling Spring Lakes as it is believed that he lived here for a short period. After the feature aired, the North Carolina State Bureau of Investigation received new information regarding the case. The information led to the development of new leads and witnesses. Detective Smith – who had been working on this case since 2014 – was notified and he accompanied the SBI Agent to speak with an individual located out of state. The individual gave detailed information regarding the incident that occurred around the time that Mr. Smart became missing and this led to the arrest of Brian O'Daniels for Murder on July 1, 2019.

The witness also gave information regarding the location of Mr. Smart's remains but, as the remains were in a rural forested area, the exact location could not be pinpointed. This did not deter Detective Smith as he studied Satellite maps and walked the woods alone in an effort to locate a probable location to find the remains. On September 10, Detective Smith had found a location that may have been a possible resting place so a "dig" was initiated. The State Bureau of Investigation, NC Forestry Service and researchers from NC State University assisted in the dig. Within 30 minutes of the start of the dig, skeletal remains were located and those remains were later determined to be those of Timothy Smart. The location of the remains not only helped to solidify the case but – more importantly – it brought closure to the family and all those involved. Mr. Smart's remains have since been sent back to his family for proper burial.

Dear Chief Tickle,

We are a small volunteer fire department in rural eastern North Carolina (Hyde County). Our department was organized in 1971. We are an IRS recognized 501(c)(4). We currently operate with nineteen unpaid volunteers providing not only fire incident response, but also first responder service for medical emergencies in a district of 176.547 square miles. We are located on Mainland Hyde County, in the county seat of Swan Quarter. We are separated from Ocracoke Island, which is also part of Hyde County by about 25 miles of the Pamlico Sound.

Mainland Hyde County's 758.577 square miles is served by five volunteer fire departments (Engelhard, Fairfield, Ponzer, Scranton, and Swan Quarter). The (2018) population of the entire county was 5,230 with about 900 of those being full-time residents on Ocracoke island. Ocracoke also is served by their own volunteer fire department.

Our department is presently working towards establishing a substation in the central mainland Lake Comfort area, which will increase our overall district. And, we have mutual aid agreements with all of the other Mainland VFDs.

We understand that your Department has a surplus 1987 Simon-Duplex LTI Ladder Truck and we are wondering if you would consider donating this truck to our department. Except for a small ladder truck on Ocracoke island, there has never been another ladder truck in the county. Actually, there is no ladder truck available within one and one-half hour drive of the Mainland.

Hyde County is a large agricultural county with a lot of grain bins. Our department has an active agri-rescue presence on the Mainland, with equipment such as grain bin tubes and training to safely evacuate someone from a grain bin if the need arose. Having a ladder truck would immensely help in such an operation. Additionally there is the Hyde County Government Center and many older two and three story homes that would benefit from a ladder truck being in the county in case of fire. If our plans work out for a new substation, we envision that your ladder truck would be used as the 'first-out' truck from the new substation.

We've attached a copy of our 2020 budget. As I mentioned to you on the phone, only \$17,250.00 in funding comes from the County of Hyde. The remainder of our income shown on the budget from the County is payment for our First Responder calls.








City Manager's Report Property Tax Collections


POWELL BILL REVENUE BY FISCAL YEAR


