#### 6. Public Comments ~

## Marge Pennington ~ 301 South Shore Dr.

Mrs. Pennington requested an update on the police department and the status.

Mr. Repp explained there is an update in the City Managers Report in the agenda packet. The architects are still working on the construction-drawing phase of the project; they have completed phase one (1) and are about 75% done with phase two (2) of the project. Phase three (3) will be the actual production of the documents that will lead to the construction estimate. Mr. Repp stated that the project will be ready for bid in late 2017. Mr. Repp also updated the ongoing issue of the ice machine reporting the property owner has obtained all permits and will begin construction soon.

## Ron Combopiano ~ 146 Forest La.

Mr. Combopiano stated he owns a rental home on 1093 Poplar Rd. It appears in the last few months the corner lot next to mine has become overgrown and someone has removed the brush, which revealed a trailer that has been gutted, the trailer is falling apart and burned out. It appears the owners have not paid taxes in a few years. I have been informed from realtors that my property value is suffering due to the condition of the corner lot. Mr. Combopiano inquired what plan is in place by the city for the removal of these types of conditions.

With regard to the land use plan and the growth area in the city and the business development of the corridor, Mr. Combopiano inquired if there is no business development committee, would it be the responsibility of the board to promote this growth? What is the board doing to bring more business into the area? In addition, a grocery store and a pharmacy would certainly bring enhancement to the city.

Commissioner Putnam commented a few years ago he spoke with the owner of Piggly Wiggly who owns land along the 87 corridor and the grocery chain would not consider building until the city had a population of somewhere between 14,000 to 16,000.

### 9. Committee / Board Reports ~

## a. Community Appearance Commissioner ~ Ann Hollingsworth

Ms. Hollingsworth reported the Commission continues working on their calendars for 2018; our property recognitions start in April and we will be meeting this month; and our welcome packages are doing well.

## b. Planning Board ~ Bill Clark

Mr. Clark informed everyone the Board is continuing to meet with Wes MacLoud of the COG and our building inspector, Ruth Bek, our Building Inspector attended. We are reviewing Chapters 5 and 6 supplemental conditions. Commissioner Stilwell inquired in Chapter 5 and 6 in what areas are you concentrating. Mr. Clark stated the Board is working on consolidations of the sections, we are also making some minor changes in the setbacks. Commissioner Stilwell inquired if there are discussions for new businesses. Mr. Clark commented we have allowed some businesses in the C-1 and C-1A. Commissioner Stilwell also inquired if the Planning Board discusses conditions for new businesses in certain areas. Mr. Clark stated there have been businesses that are allowed in the C-1 and C-1A light industrial.

#### c. Parks & Recreation Advisory Board ~ Robert Stanley

Mr. Stanley informed the Board Dr. Herstine updated the Advisory Board on the master plan and our sub-committees all gave their reports.

## d. Special Events ~ Michele Hennessey (excused)

Commissioner Crawford reported the eggstravaganza would be held on Saturday, April 8<sup>th</sup> between 11:00 a.m. and 2:00 p.m. at Spring Lake Park. The Easter Bunny will be there, also there will be an Easter egg hunt along with crafts and a cake walk. We are finalizing the plans for the Spring Fling on May 20<sup>th</sup> at Spring Lake Park; we will have vendors, games, a car show and B-B-Q cook off.

#### e. Library Commission ~ Frances Thomas

Mrs. Thomas expressed thanks to Sherrie Kuzian for all the work she did at the storage unit. We had a book buying day at Barnes & Nobel in March and purchased approximately 20 books, some are children's books.

## f. BSL Fire / Rescue ~ Commissioner Stewart (excused)

Commissioner Putnam reported there were 38 medical calls for the month of March and 31 fire, car accidents, investigations and brush fires. The Fire Department covered the large woods fire on Monday, March 6, 2017 with five (5) mutual aid departments

and the NC Forestry also responded. CPR certification class was held and testing of hoses and ladders were completed; and the checking of hydrants will continue during the month.

10. City Manager's Monthly Report ~ Jeff Repp

City Manager Repp reported as of February 28, 2017 the City had \$2,673,112 in cash and investments. 92.2% of the property taxes has been collected as of February 28, 2017; we had four (4) new residential permits issued in February and \$608,742 in construction activity. The landscape project along Highway NC 87 is released to the DOT for bid until April 6, 2017 at 2:00 p.m. Assuming the DOT has a successful bidder, the work will begin on May 8, 2017 and the completion for this project is July 14, 2017. The city is close to finalizing the purchase of the vacant lot on Holly Road.
