# COMMUNITY APPEARANCE COMMISSION MEETING MINUTES City Hall March 16, 2015 7:00 P.M.

#### I. Call to Order

The regular monthly meeting of the Community Appearance Commission was called to order by Chairman Ann Hollingsworth at 6:59 p.m.

Ann also suggested a picture of the Committee members to be part of the collage of pictures on the cover of the calendar. Commissioner Putnam stated that unfortunately the County will not have the Welcome Signs landscaped by the time the calendar goes to printing.

Following were some of the pictures discussed for the calendar: azaleas, red cockaded woodpecker, Venus fly trap, redheaded woodpecker, picture of the Big Lake, sunset on the Big Lake, snowy picture of the Big Lake, blue birds, cardinal, fox squirrel, long leaf pine with pinecone, dock/lake picture.

Commissioner Putnam thought it was important to include the history of the City that was used on the previous calendar since there are new people moving to the City that do not know the history. The information from the magnet should also be included on the back of the calendar. Ann anticipated selling the calendars for \$10 each as she has in the past.
