# COMMUNITY APPEARANCE COMMISSION MEETING MINUTES November 20, 2017 7:00 P.M. City Hall

#### I. Call to Order

Chairperson Ann Hollingsworth called the regular monthly meeting of the Community Appearance Commission to order at 6:55 p.m.

# II. Approval of Agenda

# V. Old Business

#### a. 2018 calendar sales ~ update

Ann noted that Carmen Berk sold seven calendars at the Candidates' Forum and Zee and Dorothea sold five calendars for a total of \$120 in calendar sales.

# b. Certificate of Appreciation

Ann noted that the committee has nominated people and city departments for Certificates of Appreciation in the past and this time she would like to recognize a committee volunteer. This person is someone who has gone above and beyond the call of duty for her committee, always does what is asked of her and always has a positive attitude. This person is Carmen Berk. Ann would like to nominate Carmen to receive a Certificate of Appreciation and a gold star for all she does for the Community Appearance Committee.

#### c. National Prayer Day

Ann explained that last year the committee celebrated National Prayer day with the Mayor and Commissioner Putnam. She asked the committee if they would be interested in celebrating National Prayer Day again this year, which will be on May 4<sup>th</sup>. She would like to ask Lee Eiss, the City's Chaplain, if he would lead the committee in prayer. She would like to invite the Mayor, the Commissioners and any of the other committees to participate. Zee thought it would be nice to celebrate the day and to be positive in life because the more we do as people, the better we are.

#### d. Welcome Packages

Ann asked the members if they had any ideas for something they could purchase for the Welcome Packages. They currently have the reusable shopping tote, jar opener, and the magnet with the City, Police Department and Community Center phone numbers and address of City Hall. Previously they had seed packets and small peat planters. Dorothea suggested pens with the City's logo and name. Ann suggested chip clips with the City logo and name and they could put the chip clip at the top of the bag to keep it closed when presenting it to new residents. The cost of the chip clips would be \$0.87 for 250 clips which totals \$217.50 not including shipping and handling as per the catalogue where they ordered the bags.

A Motion was made by Zee Rygg and seconded by Dorothea Roberts to purchase 250 chip clips at the approximate cost of \$217.50 plus shipping.

Ann suggested ordering the chip clips in white or the frosted color with blue lettering if possible to coordinate with the bags. The committee will discuss ordering pens for the Welcome Packages at the February meeting.

Carmen Berk will deliver to: 1047 Morehead, 2011 Pinehurst, 540 Kennedy and 1421 Cottage Lane.

The following packages were delivered since the last meeting: 714 E. Boiling Spring, 1310 Maple, 581 Greenmoss, 562 Greenmoss, 200 Bordeaux, 118 Fairway, 1460 Cottage and 207 Cherry.

Zee was unable to deliver a package to 1345 E. Boiling Spring Road as the home was not yet finished.

The members put together their Welcome Packages with the flyers and brochures Pamela had printed earlier in the week.

Zee commented how nice the website looked and it was pleasure accessing it.

Ann noted that Kai Joe's would be opening an eatery at the former Baked with Love restaurant in Southport.
