# COMMUNITY APPEARANCE COMMISSION MEETING MINUTES April 17, 2017 7:00 P.M. City Hall

## I. Call to Order

## V. Old Business

# a. Welcome Package Items

Ann noted they only have about 70 blue Welcome bags left and there are plenty of jar openers but asked the members if they were interested in adding the flowers pots discussed at the last meeting to the Welcome Packages. The members discussed which flower pot they preferred and agreed to the biodegradable pots.

A Motion was made by Carmen Berk and seconded by Carmen Suits to purchase 100 biodegradable pots for \$17.50 plus tax and shipping.

Carmen Berk acquired more brochures from The Office Wine & Coffee Bar for the Welcome Packages.

# c. Highway 87 Update

Commissioner Putnam advised the DOT has put out for bid the landscape project along Highway 87 and at the Welcome signs. The project will begin on May 8<sup>th</sup> and must be completed by July 14<sup>th</sup>. The landscaping project will be done according to the landscape architect plan previously submitted by the City to the DOT.

Carmen Suits asked Commissioner Putnam to bring to the next meeting the landscape architect plan for the members to view again now that the project will finally begin.

# d. Spring Fling ~ May 20, 2017

Ann asked Pamela to get home recognition pictures printed for the frames as well as pictures submitted for the calendar. Ann will get the basket of information ready for the event.

# e. 2017/2018 Fiscal Year Budget

Ann recapped Commissioner Putnam helped the Commission with the budget request of \$400 for the 2017/2018 fiscal year budget. Karen Thompson provided a printout for Ann showing the budget request for the Commission.
