# VI. New Business

# a. Christmas Property Recognition

Before discussing the Christmas property recognition, Ann reminded the members that 99 Dunn was nominated last month for property recognition and asked if everyone viewed the home and agreed to place a sign on their property. The members unanimously agreed. Dorothea took a picture of the home, which she sent to Pamela. Pamela received a signed photo Release from the homeowner.

#### b. Welcome Packages

Commissioner Auger apologized for his absence from the past few meetings explaining the hurricane has taken a lot of his time away. He also explained they were waiting on the Storm Water Engineer to get the plan together for that system.
