## b. Book Social

Frances and Tammy will be going to The Office to speak with Mr. Warner about the possibility of using a few shelves for books to sell. The Office would not be responsible for handling the purchase of the books as it would be on the honor system with a cash box for people to put money in.

Frances and Tammy will also speak with Mr. Warner about holding a Meet the Author event at The Office. The members discussed Authors they had previously considered for events as well as Frank Williams who has his new book out, *Convergence*.
