## 4. NEW BUSINESS

## A. Wheel of Fun Rentals

Mary Green explained this company is supplying the paddle boats on the set for the movie "Tammy" being filmed at Spring Lake Park. The franchise owner spoke to Mary Green about setting up permanently or seasonally. He explained it could be very beneficial for the city because it is additional amenities that would be provided for the residents and would be not cost the city money. Currently they have a franchise in Carolina Beach. The franchise pays Carolina Beach twelve percent of any revenue they generate. It would be no out of pocket money from the city. Mary Green distributed a package provided by the company to explain what they offer. They offer bicycles, kayaks, peddle boats etc. Boiling Spring Lakes does not have the infrastructure for bicycles but does for the other amenities they offer. The City would lease the land to the company and they would be responsible to build what

they need to keep their items secure and any type of launching facilities for the boats. They would also be responsible for the insurance, staffing, maintenance, staffing and any permits needed. Mary Green explained any type of recommendation that would come from the Parks and Recreation Advisory Board as far as gathering more information and fee structure; she would get that and present it to the Board of Commissioners.

Mary Green explained further there would be a million dollar insurance policy which is required for all vendors and businesses and would name Boiling Spring Lakes as additionally insured and releases, safety checks. The Wheel of Fun entity has been in business for a long time. Page four of the packet that was distributed explained the turn key operation financials. They handle cost of equipment repairs and replacements, cost of product refurbishment, risk management, advertising, insurance, logos, licenses, permits, rental and storage building and opening cost including set up.

Melissa Thomas confirmed with Mary Green there is no cost to the city and the city has the potential to earn a percentage of the rentals. It will not use any city staff. The Advisory Board agreed it would be a good addition. Bruce Pennington asked if the company would have a good enough turn over to keep it going. Mary Green explained it would be up to the company. They would have to judge if they could price it appropriately for the area.

Charlie Carroll explained it would be good to look into the information that was given. He would like to ask the City Attorney to look over the information to be sure the insurance is enough and if it is a good idea. When you get an opportunity for an additional amenity it would be good to look at it. Mary Green explained water activities are considered an open and obvious risk in North Carolina.

Suzanne Goffredo asked if it were to go through would it be this summer. Mary Green responded it would be up to the business owner and the Board of Commissioners.

A motion was made by Sandra Krasnow and seconded by Suzanne Goffredo to move forward and send this information on to the Board of Commissioners.
