#### 1. CALL TO ORDER ~

The meeting was called to order by Bruce Pennington at 6:30 p.m.

# 5. OLD BUSINESSS ~

# A. Survey ~ distribution update.

Mary Green was absent from the meeting and will present an update at the August meeting.

The attending board members stated they have been handing out or emailing the surveys and requesting that they be returned either to City Hall or to the Community Center. It was also discussed that the board members were awaiting an email with the link to Survey Monkey.

# 6. NEW BUSINESS ~

# A. Lighting at tennis / basketball courts

Bon Cantrell had visited the house next to the tennis and basketball courts on two occasions but there was no answer at the door. He will make the attempt again before the next meeting to visit the house at a different time hoping to catch the resident. He has researched different types of lighting available for the courts – directional and timed. The kids are at the park this time of year until 8:30 at night so he is hoping that the surrounding residents would not have an issue with the courts being lit until that time of night during the fall and winter months.

# **B.** Election of New Chairperson

Commissioner Stilwell requested by email that the election be postponed until she returns for the August meeting.

# C. Discussion on Foot Wash at Spring Lake Park

Commission Glidden stated that this issue was brought up at the July 14<sup>th</sup> Citizens' Forum. The resident requested that a foot wash be located in Spring Lake Park so sand could be washed off before leaving the park. Commission Glidden advised the resident that said request should be brought up to the Parks and Recreation Advisory Board as it pertains to a park. Commissioner Glidden reminded the board members that the water spigot located at the Margaret Davis Garden at Spring Lake Park is not well water and the City would be charged for water usage by the County for the foot wash. Commissioner Glidden also suggested that the device to be considered should have an automatic shut off so the water could not be left running and that it should be removed in the winter. Concerns were expressed about the foot wash possibly being vandalized by kids who hang around at the park. A suggestion was made that if a bathroom were

installed at the park, the foot wash could be run from the water for the bathroom however it was stated that a bathroom would require a septic system.

A motion was made by Verda Darrell and seconded by Bob Stanley to table the Foot Wash station at Spring Lake discussion until the next meeting.

**Discussion:** Bruce Pennington stated a concern was brought to his attention about dogs at Spring Lake Park. There is a sign that states no dogs allowed at the park however people have been seen with dogs at the park. The people concerned did not know how they should handle the situation. Commissioner Glidden stated that she is working on this this issue with the Chief of Police because the City ordinances are vague and hard to enforce. They are working on leash laws, dogs in Spring Lake Park and North Lake as it pertains to a dogs allowed park and will be on the agenda at the August Board of Commissioner's meeting.

Verda Darrell expressed her concerns about dogs roaming free in the City who are not on leashes or behind fencing as she had been attacked twice while she walks around the City and can now no longer walk in those areas because of the dog attacks. She feels that the residents should be able to walk wherever they want to walk but cannot do so if dogs are allowed to roam free without supervision or being restrained. Commissioner Glidden stated that Chief Shirley is looking into updating the animal control ordinance and the issue will be addressed in August at the Board of Commissioner's meeting.
