Vice Chair Dory Manz called the monthly meeting of the Parks and Recreation Advisory Board to order at 6:00 PM.

IV. Old Business

a. North Lake Property Acquisition

Parks & Recreation Director updated the board on the completed property acquisition adjacent to North Lake Park (Parcel # 142PA00203 & 142PA00205). The City is currently exploring two additional lots (Parcel # 142PA00901 & 142PA00204). Lakeview Drive is currently under construction. Once complete, the shade canopy and portable toilet will be replaced.

b. Pedestrian Plan

Parks & Recreation Director announced the next steering committee meeting with NCDOT & AECOM will be held at 5:00 PM on 1/28/20 with the first of the public meetings to follow at 6:30pm. Both meeting to be held in the commissioner chambers at BSL City Hall.

c. Muse Park Redevelopment

Parks & Recreation Director announced that the final stages of planning are underway. Parking and stormwater permitting are the final two stages prior to the project being started. Groundbreaking goal is April 2020.

d. Wake Boats

Discussion by board members included the banning of commercial and recreational wake boats on Patricia Lake (Big Lake) to prevent shoreline erosion. Prior to making a decision, the board agreed with the Parks & Recreation Director that further research into the boats are needed. Mary Green agreed to put together a power point presentation for the February meeting to show how these boats create the wake and how the lake bed handles the wakes.
