Duplex ~

Bill Clark explained, currently duplexes are only allowed in the R-4 District. The R-4 district is one side of Cherry Road. The board discussed other zoning districts to allow them in. Tom VonVoigt explained they should be allowed in all zoning areas if they are in one. Bill Sraver stated he did not agree they should be allowed in all zoning areas if they are in one. Bill Sraver explained that is why we have zoning. The voting members of the board agreed to allow duplex's in all residential zones.

6.52 Patio/Cluster Homes / Duplex Homes

Duplex, two family houses shall be permitted in all residential zoning districts.

A. The duplex housing shall conform to article 5.6.2 and article 6.8 of the Boiling Spring Lakes Unified Development Ordinance.
