#### **NEW BUSINESS:**

#### 1. Orphaned Ponds

The Board held a discussion regarding ponds owned by Reeves Telecomm, and ponds for which owner information is unknown. Bill Sraver explained his property backs up to a pond on Grant Circle. After one of his neighbors pumped water out of the pond, he contacted the City and was advised by Ruth Bek the pond on Grant Circle is owned by Reeves Telecomm. Bill Sraver then stated he would like the Board to present a request to the Board of Commissioners that the City take possession of these orphaned ponds.

At one time, Bill Clark stated, Reeves Telecomm offered to turn such property over to the City. The City, at that time, did not choose to take possession. The Board reviewed a map of the ponds owned by Reeves Telecomm, as well as the ponds for which owner information is not listed on the County GIS map. Sam Andrus, residing at North Shore Dr., asked the Board if the City would need to follow a stormwater management plan should the City take possession. Bill Clark explained nothing on the lots would be changing, should the City take possession. Paul Fry, residing at Acacia Dr., explained his property backs up to a pond owned by Reeves Telecomm, and stated many of the ponds are land locked. The Board reviewed the map and agreed. Bill Sraver stated the City could obtain easements to access these ponds and Paul Fry noted many of the properties would not have enough room to provide such easements.

The Board agreed that, looking ahead, it may be in the City's best interest that the City take possession of such ponds. Bill Clark suggested the Board conduct more research into these ponds before making a final determination.

A motion was made by Lucille Launderville and seconded by Bill Sraver to table the discussion on orphaned ponds until the December 11, 2018 meeting.
