NEW BUSINESS:

1. Unified Development Ordinance 2021 Update-N.C.G.S. Chapter 160D Nicole Morgan explained in 2019 General assembly legislation creating Chapter 160D which consolidates current city (160A) and county (153A) enabling states into one single, unified chapter. These updates do not make major policy changes or shifts in the scope of authority granted to local governments, but the new legislation does provide clarifying amendments and consensus reforms which must be incorporated into local development regulations. Ms. Nicole Morgan also reported local governments have until July 1, 2021 for the development, consideration and adoption of the necessary amendments to conform ordinances to the new law.

Nicole Morgan reviewed Articles 1 through 11 and Appendix A of the Unified Development Ordinance with the Board and explained various amendments required by the new legislation. The Board reviewed the new and omitted text in Articles 1-11, and had no questions for Nicole Morgan. Nicole Morgan explained there are no changes necessary for Article 12, Appendix B, or Appendix C.
