B. Chairman Mary Stilwell wanted to thank everyone for coming out to her Open House last month. She was very pleased that the new Police Chief came by, and she is very excited to begin working with him.

OLD BUSINESS:

A. 2013 Dates

Michelle Hennessey is going to begin spreading the word and handing out the dates for 2013 events. Making sure all the big spots are taken care of. This ensures that everywhere has plenty of notice, and all businesses can let customers know.

Mary Stilwell stated she would much rather spend money locally for a local business rather than online. Melina is checking into prices.

E. Sound System

The Committee is going to start looking at getting a sound system. It is mostly needed for the Haunted Hay Ride, however it is also needed for announcing at events, because they can't be heard.

F. Sponsor Letters

Elizabeth Snyder has made incredible sponsor letters to send out for the 2013 year. She has a couples letters prepared, and she would like the Committee to let her know of any "contacts" they have at these businesses, so when the letters are sent out she can make a follow up phone call for the donations.

Chairman Stilwell would like these to go out as soon as possible. Mary also stated she would hand write the envelopes for the sponsors because she appreciated it so much, and it was more personable.

The Committee is sending out thank you pictures for the sponsors to hang in their facilities, they are going to look in to getting frames. Commissioner Carroll has a template he is going to send Mary Stilwell and she will decide how she wants them done.

NEW BUSINESS:

A. Spring Bike Run

This year's theme for the Bike Run will be "Ride for a Child". The members are going to start looking for a child in need inside the City that has ongoing medical problems that they could sponsor and make a donation too. Chairman Stilwell is going to ask the Board of Commissioners if she can't locate one in the City can they do a surrounding area.

All the Committee Members would like the Child to ride in one of the Police cars for the ride. They think they would really enjoy being a part of the event.

Melina is going to focus on doing hamburgers for the event this year. She is going to talk to local grocery stores about donating the hamburger meet, and of course having all the great sides to go along with them!

Commissioner Carroll is working on a new route that the bikers can take this year. He has one in mind, and he is going to take Mary Stilwell on it, and let her make the decision. The new route would take them off of Highway 17 for the most part, and just all around change it up for the participants.

Melina Trivette said she might have another group of bikers that she could extend the invitation too. She is going to make sure they have bikes that are street legal, and notify them of the event.

The Committee would also like the JROTC from South Brunswick High School to come out and help again. She would like to ask them to be there around 10:15 for the Color Guard, and have the ones that can help set up tables to be there around 8:30 a.m. Again, the Spring Bike run is taking place on April 13, 2013.

B. Fun Day

Chairman Stilwell brought an idea to the Committee and asked if they would be ok in having the theme be Supporting our Troops. Everyone thought that was an excellent idea, and Mary Stilwell is trying to get the Marine Band to come down and be the entertainment.

She also must talk to the Church about the blow up bouncy machines, and to see if they have insurance. If not, the Committee is going to have to kick up the entertainment for the kids.

The Committee needs to new vendors, and new booths this year for Community Fun day. Commissioner Carroll spoke with Cheryl Riker, and she would like to bring a D.A.R.E. booth out with the Sherriff's Department. Mary Stilwell said she would speak with Cheryl and her husband and find out more information.
