AN ORDINANCE AMENDING CHAPTER 2 – ADMINISTRATION, ARTICLE III – BOARDS, COMMITTEES AND COMMISSIONS, DIVISION 7 – SPECIAL EVENTS COMMITTEE OF THE CODE OF ORDINANCES FOR THE CITY OF BOILING SPRING LAKES.

WHEREAS, the Board of Commissioners desire to amend the above section of the Code of Ordinances; and

*NOW, THEREFORE, BE IT ORDAINED, THAT:* 

Section 1. That the following sections of the Code of Ordinances are amended as follows: Sec. 2-123. - Creation; name; number of members.

- (a) There is hereby created and established a special committee to be known as the special events committee. The special events committee will be composed of five (5) individuals who are permanent residents of the city. [All members must be residents of the city at the time of appointment; however, if a committee member were to move from the city during their term, they may remain on the committee to finish their term. At term end, the member would not be permitted to be reappointed for an additional term.]
- (b) [The board of commissioners may appoint two (2) additional members, who shall be characterized as alternate members. The alternate member with the most seniority shall be considered the first alternate and the other member shall be considered the second alternate.

  Alternate members are required to attend all meetings, however they may only vote when a regular board member is absent based on seniority. A quorum shall be determined based upon the membership number of five (5). The alternate members shall be appointed for terms of two (2) years and are eligible for reappointment.]

#### Sec. 2-123.1. - Powers and duties.

(a) The special events committee shall oversee and help organize and staff city sponsored events.

such as spring fling at the lake, mayor's golf tournament, battle of the bands, 9/11 memorial

bike ride and the annual tree lighting, haunted hayride, raft race, as well as other events. All

events are approved by the board of commissioners with all funds raised donated to community

non-profit organizations.

Sec. 2-123.2. - Appointment; terms; vacancies.

The board of commissioners shall] appoint two (2) members, one (1) of whom shall serve for a one year term, and one (1) of whom shall serve for a two year term. After the initial terms, all [All] further terms of office shall be for three (3) years for each member. Members shall be eligible for reappointment.

Members may be terminated for missing three (3) consecutive meetings without legitimate reason and without having notified the special events chairman. Vacancies occurring for reasons other than expiration of terms shall be filled as they occur for the period of the unexpired term. [If a regular board member should tender a letter of resignation or be removed for missing meetings without legitimate reason, the vacant position shall be filled by an alternate based on seniority and shall be appointed by the board of commissioners to fill the vacancy and a new alternate shall be appointed in his place.

Vacancies occurring due to the expiration of term shall be filled by either the reappointment of the current board member or by the appointment of an alternate board member based on seniority.]

Sec. 2-123.3. - Meetings.

Meetings of the special events committee shall be held at [a time and date as determined by the committee] 6:00 p.m. on the second Wednesday of each month at the city hall. Regular monthly meetings shall not be required, and additional meetings may be held as needed for planning events at a date and time determined by the committee. The chairman of the special events committee shall call a
