The committee received \$500 from the 50/50 raffle and \$480 from The Lakes Golf Club, leaving us with a balance of \$3,811.76.

#### b. Candidates Forum

Ann Hollingsworth, Chairman of the Appearance Commission, was a guest at our meeting. The Appearance Commission is joining our committee in putting the forum together. Ann spoke to Commissioner Witt about our concern for a location large enough to accommodate our citizens and our concerns regarding the outbreak of COVID. Commissioner Witt suggested to Ann that maybe putting it on virtually might work.

The committee discussed this possibility and are hoping they can use City Hall and have it virtual. There was discussion regarding asking the candidates questions and having citizens submit questions and the most consistent questions sent in would be used. Joan will check tomorrow regarding the possibility of using City Hall and will let the committee know her findings.

Because there are so many decisions we cannot make at this time, we plan to meet with the Appearance Committee on Monday, September 20, 2021 at 5:00 PM to finalize our plans so we can let the citizens know. Flyers will have to be made and letters will need to be written inviting the candidates.

There was discussion regarding who would moderate the forum and Joan suggested Devon Varnam, pastor of Southport Baptist Church to moderate. He is a Boiling Spring Lakes citizen. She will ask Devon if he would be willing to moderate for us.

### b. Tree Lighting

A motion was made by Brenda and seconded by Joan to have Lucille purchase 4 – 5 strings of lights for decorating the city Christmas tree.
