Boiling Spring Lakes Mayor and Board of Commissioners to Hold Informational Meeting on 247 acre Land Donation Proposal on Monday, January 6, 2014 at 6 p.m..

The City of Boiling Spring Lakes announced today that the Board of Commissioners will be meeting in a special session on Monday, January 6, 2014 p.m. at City Hall to present to the public and receive public comment on a proposal from the Works of Life International Ministries of Clovis, CA to donate 247± acres of land that the group received from Reeves Telecom Limited Partnership in October 2013.

"The City has been approached by this non-profit group to consider the donation from this group of 23 parcels of land totaling 247 acres. All but 23 acres is located within the commercial corridor of the City along Hwy 87 with the largest parcel being 146 acres. The Board of Commissioners want to inform the citizens of this offer and receive feedback from those citizens before formally considering this proposal at their January 7th public meeting," stated City Manager Jeff Repp.

While the property would be donated at no cost to the City, 20 of the 23 parcels will soon have assessment liens placed on them by Brunswick County government for the recently completed sewer system along the Hwy 87 corridor. The estimated value of those assessments to be levied is \$ 876,572. The assessed value of the 23 parcels is \$ 4,548,670 according to Brunswick County tax records.

"The Board of Commissioners is well aware of the financial implications if they were to vote for the acceptance of this donation," added Mr. Repp. "Before considering the matter the Board felt very strongly that they wanted to hear from the public before deciding one way or another on this offer which will take place at the January 7th public meeting. They encourage the public to attend the January 6th meeting to hear more about the proposal and then make their comments know to the full board that evening."
