# Parks and Recreation Advisory Board Meeting Minutes January 19, 2022 6:00 P.M. City Hall

#### I. Call to Order

Barbara Bennett-Snyder called the meeting to order at 6:02 pm

Sara Goodwin, new interim Parks and Recreation Director/Recreation Supervisor for Seniors was introduced to the board.

## V. Director's Monthly Report

Sara shared that they are short staffed at the Community Center, as both she and Sara Vroman are working two positions each. She has submitted to David, the town manager, what each staff member makes and who oversees which programs. She has asked for a raise for Tina, who works the 6-9am and 3-6 pm shifts, because she is so dependable and has been faithful to stay with the program through all the changes. There is one before school position

open as well. Mary's position will be advertised this week, they will take applications for 30 days and then interview and make a choice. Sara Vroman's position is interim for 3 months. The youth program is maxed out with the limited staff, there are 14 children before school and 28 after school. Also, masks are once again required in the Community Center.

Barbara reports that Kathy says the dog park rules are being followed, Bruce concurs (except for the geese, who don't pick up their poop) Stephen has a problem with the lack of adequate signage at the parks, mainly for emergency responders. There is no street name on the park signs. Tom suggested that Sara put it on a 'want' list for Public Works, and/or the board can make a recommendation to take to the Board of Commissioners. It was also noted that the sign at the end of Spring Lake still says No Dogs, right next to the sign that says it is a Dog Park.

There are projects here that would be good for the Boy Scouts, like the compost bin and many others. Adopt a Box is another idea. The idea of sponsorships for classes and boxes was discussed. Do we solicit businesses? Do we contact the media? Tom suggests sponsorships for people to be able to attend a class, such as bale gardening that was also discussed. Barbara will make a flyer for sponsorships and let Sara edit and publish it.
