Planning Board Workshop January 21, 2023 9:00 A.M. ~ City Hall

CALL TO ORDER:

The Planning Board meeting was held at City Hall on Jan 21, 2023. Chris Frazer, called the workshop to order at 9:00 A.M.

Chris Fraser called the meeting to order. He introduced Gorgon Hargrove and Mark Bloomer and welcomed everyone.

McKay Siegel of East/West Partners presented a power point slide presentation on Choosing a developers. Giving insights on what to look for and what to be aware of. Mr. Siegel suggested the Planning Board read *Walkable City* by Jeff Speck. Mr. Siegel talked about character of what was being designed and built. 'Don't be afraid of Development. Be afraid of bad Development." He discussed economics, stating "a mile of road costs a mile of road whether it's got one house or 100 houses." He also spoke on preserving the environment, save the trees. As far as the traffic, "build house closer to where people want to go anyways." Mr. Siegel encouraged the city to be open to the "Hipsters", telling on how they have helped to bring in business to cities in the past. Mr. Siegel reiterated that storm water can be

costly if not managed properly.

Chris Frazer explained the DOT Activity to everyone there. At that point everyone was encouraged to go around and use their dots to vote on what they wanted to see or use in a City Center Master Plan.
