**NEW BUSINESS: Brunswick County Comprehensive Transportation Plan** 

**Presentation** 

Nicole Morgan explained to the Board the history of the Brunswick County Comprehensive Transportation Plan (CTP), how it was started back in 2021 then put on hold in 2022 and restarted in Feb 2023. She also stated that the county had 3 in person meeting in May of 2023. She clarified what the CTP was and how it is a plan to be use short term and long term. There are Highway Recommendations, Bicycle/Pedestrian and Rail/Public Transit and Ferry sections to the plan. She reviewed some of the items that concerned BSL. She shared what some of the plans was to include in the short term plan and what some of the long term plan included. There was discussion on Highway 87 and what the Board would like to see. The feedback from the surveys were the road needed to be wider and sidewalks needed to be added. Ms. Morgan confirmed that the NCDOT lowered the speed limit on Cougar Dr. from 35 mph to 25 mph. There was discussions on having traffic circles installed. Ms. Morgan explained that the CTP would have to be adopted by the Board of Commissioners, she would like to have endorsement form the Planning Board for the CTP. She also stated that the City would be able to have some say in that was done. This was an informational workshop for the Planning Board.
